Police said she was flown by

helicopter to a confinement facility outside the city.

The man was identified as Gerhard Mueller, who was making a telephone call from a nearby phone booth when arrested by two policemen.

Police had received a tip as to where the two were hiding and had traced their move-

It was believed that the two might have arrived here from West Berlin.

Police said Mueller, 24, has not previously been identified as a member of the Baader-Meinhof gang. Police described him as a known homosexual.

Butte said the telephoned tip

reported a suspect man and woman had moved into a private apartment at 11 Walsroderstrasse in Langenhagen near the city's airport.

Police surrounded the building, but made their move only after Mueller, who apparently was serving as Miss Meinhof's bodyguard, left the apartment to make a telephone call.

A police spokesman indicated

that she did not arm herself before answering the door when
they rang the bell.

Of the "hard core" members
of the gang, only 18-year-old
lise Stachowiak remains at

large, although lesser members

may be hiding in Denmark, police said.

Miss Meinhof was believed linked to a West Berlin apartment that was wrecked by explosives earlier this month. It was soon after the blast that two more members of the gang, Bernhard Braun, 26, and Brig-itte Mohnhaupt, 22, were pick-ed up by Berlin police in an-other apartment living under assumed names.

Another hard-core member of the gang, Gudrun Ensslin, was apprehended two days earlier in a Hamburg boutique. She was carrying a pistol in

her handbag.

Braun and Miss Mohnhaupt were vastly changed in their outward appearance from pictures being circulated by authorities throughout the countries.

Miss Meinhof, the ideological leader of the Baader-Meinhof gang, has been sought since May 1970, when Baader was freed from police custody in West Berlin while serving a three-year sentence for a politically motivated arsonist attack on a Frankfurt department

Police officials said that she engineered the escape in which a policeman was shot and wounded. B a a der's escape marked the beginning of politically motivated criminal activities including bank holdups, car thefts, shootouts with police and terrorist bombing at-

The rash of bank robberies

The rash of bank robberies is believed to have netted the gang more than \$60,000.

Ulrike, a 37-year-old divorcee who has two children, used the aliases Anna and Rana. Her parents were art historians and died when she was a constant of the state of the died when she was a young girl. Police said she was raised by Renate Riemeck, a West Berlin Free University professor, who introduced Ulrike to

"leftist thinking."
In Hamburg, she met leftist journalist Klaus-Rainer Roehl, who published the student paper Konkret. Ulrike worked on the paper's staff. They married, and were divorced in 1968

The gang, modeling itself after South American and Arab urban guerrillas, had been sought in connection with a wave of bombing attacks that left four U.S. soldiers dead and

36 Americans and Germans injured.

The arrest of Ulrike brings to seven the number of alleged key figures in the gang who have been arrested since police surrounded a hideout in Frankfurt June 1 and wounded Baader in a shootout not far from U.S. Forces facilities, including the V Corps headquarters where the first bombing attack on U.S. installations occurred May 3.

# Cease-Fire

BELFAST (UPI) — Northern Ireland was generally quiet Friday as leaders of the Provisional Wing of the Irish Republican Army (IRA) considered a call by Roman Catholic politicians for a cease-fire.

A man was taken to hospital after being hit in the leg by one of seven shots fired from a

passing car in Great George St., Belfast, early Friday. In Greencastle, near Belfast, a bomb damaged the stock room of a cooperative store.

Provisional IRA sources said their leaders were meeting in Londonderry and Dublin to consider the call by leaders of the Social Democratic and Labor Party (SDLP) for a 14-day cease-fire.

SDLP leader Paddy Devlin, who issued the cease-fire appeal Thursday after a meeting in London with Northern Ireland secretary William Whitelaw, flew to Dublin Friday and on his arrival was optimistic about peace prospects.

"This afternoon significant things will be happening for peace in the North," Devlin told reporters at the airport.

15 Released

Shortly afterwards 15 men were released from the Long Kesh internment camp, where they had been held without trial under the Special Powers Act. A total of 553 men have now have get free since Whiteley, or been set free since Whitelaw assumed direct rule in Northern Ireland.

Three hundred and eighty

seven are still in custody.
In London, Prime Minister
Edward Heath called his ministers together to discuss the proposed peace talks with opposition political parties in Northern Ireland, announced by Whitelaw in the commons

Thursday. Whitelaw will also meet the SDLP leaders separately again Monday in Belfast.

## IRA Chiefs Track Bureau Consider Denies Charges Of Race Fixing

NEW YORK (AP) — The president of the Thoroughbred Racing Protective Bureau attacked Thursday the credibility of Bobby Byrne's testimony before the House Select Committee on Crime, saying he was "a common burglar who painted with a big brush."

Byrne appeared Tuesday before the committee under the alias of Mr. X, saying he had fixed races from Florida to New England by tranquilizing several horses in the field then betting the "live" ones.

"We know he tried to fix races," said Spencer J. Drayton, head of the TRPB, "but all up and down the Eastern Seaboard is a lie. We know he doesn't even know where some

doesn't even know where some of the tracks are. Besides, he couldn't have been at all of the places at all of the times he

said he was.

'Can of Worms'

"He's not telling the truth. He couldn't be telling the truth. This is a can of worms we buried years ago that he's resurrected."

Drayton told a news conference that the TRPB had apprehended Byrne April 23, 1971, while he attempted to enter the stable area at Suffolk Downs stable area at Suffolk Downs near Boston, armed with two hypodermic syringes filled with tranquilizing agents. He said that the TRPB had been investigating Byrne and his associates since May 1970 and that their findings resulted in the indictment of 39 persons in Massachusetts and Rhode Island.

Drayton said Byrne had been

Drayton said Byrne had been arrested 15 times for burglary and was just "trying to make a mittee.

Byrne testified that he had been "knocked down" at least three times for burglary.

Drayton also said the committee gave racing an un-warranted black eye by bringing up the subject of counterfeit foal certificates but not expanding on it.

He said it was his group that had uncovered one such forgery at Narragansett Park near Providence, R.I.

"Investigation revealed that the trainer, Robert Servideo, had presented a counterfeit foal

certificate bearing the name of Oriennel but bearing the registration number and markings of the horse, "Transponder," he said. "Narragansett stewards suspended owner Paul Best and trainer Servideo."

Drayton said that as a result of that incident and others now being probed by the Federal Bureau of Investigation, the Jockey Club, which certifies all

Jockey Club, which certifies all foals, was taking measures to close the loophole and eliminate the running of "ringers."

The New Jersey Racing Commission, meanwhile, also denied the allegations of Byrne concerning Garden State Race Track in Cherry Hill.

B52s also flew two missions two miles east and five miles northeast of the long-besieged city of An Loc in the 24 hours ended at noon Friday and U.S. Navy pilots hit Com-munist bunkers 20 and 25 miles northwest of Saigon.

An F4 Phantom jet hit a Soviet-made tank north of Communist-occupied Quang Tri on Thursday and another tank sitting in the midst of a fuel dump southeast of the city was blown up by the guns of the U.S. guided missile destroyer Joseph Straus offshore, the command said.

In the ground war, fighting increased Thursday in northern areas around Hue with South Vietnamese commanders reporting 57 Communist troops killed in several clashes around Fire Base King and 43 killed in fighting near Fire Base Bas-togne. Government losses were listed as seven killed and 27

## Youth Charged in Crank Threat

FRANKFURT (S&S) — A 15year-old dependent stepson of an Army specialist six has been charged with making a crank bomb threat and will go on trial at juvenile court here June 23

or 26.
"Charges against the second youth, 16, were dropped," said a V Corps spokesman. "He ap-

peared on the scene after the call was made, but before the police arrived." The youth facing trial alleged-

ly telephoned the main Frank-furt PX, May 24, the day after the Heidelberg bombing which killed three soldiers. The call was reported made from the American housing area.

According to MPs, the call was made at 10:30 a.m. The caller said, "There is a bomb in the PX, no, I mean the shopping center."

The PX was cleared for 30

minutes while a bomb search was made. The youth's stepfather is as-

signed to Hessen Support Hq.
